


Competitive Innovation Fund (CIF)

Success Story

Competitive Innovation Fund (CIF) supports and provides grant funding for higher education institutions' (HEIs) competitive initiatives with World Bank support in frames of the I2Q project.



Strategic objective of the Competitive Innovation Fund (CIF) is to foster modernisation of higher education programs and learning environment and to strengthen the labour market linkages.

CIFenables HEIs to develop priority fields and introduce innovative methodology, fully aligned with their strategic development plans.

Systemic development of education is a fundament of society's social-economic development. Introducing innovative learning-teaching methods and strengthening linkages with the labour market is of strategic importance to Georgia. This in turn stands out as a guarantee for tangible results and success.

Introducing innovation in education enables constant advancement and quality and proficiency enhancement. It assists HEIs to meet academic needs of students and staff and to adapt to the rapidly developing world.

To this purpose, with support of the World Bank, Competitive Innovation Fund (CIF) was created in frames of a project – "Innovation, Inclusion and Quality Project – Georgia" (I2Q).

Innovation is a baseline of the Competitive Innovation Fund (CIF) that is implemented by a Ministry of Education and Science of Georgia. Strategic aim of the fund is to foster modernisation of higher education academic programs and learning environment and to promote cooperation with private sector.

CIF is an alternative source of funding for the HEIs, encouraging cooperation and competition among different actors/ stakeholders. CIF speeds up constructive changes and institutional modernisation process with regards to higher education system demands.

CIF enables HEIs:

 To implement their strategic development plans aligned with the priorities and strategic fields of the state and the Ministry of Education and Science of Georgia (MES);

 Upgrade academic programs to international standards and to labour market needs;

CIF 1st Call for Proposals was announced in 2022. Based on available budget and evaluation results, 13 proposals were funded with 2,1 million USD.

COMPETITIVENESS

Healthy competitive environment was created throughout the first grant competition with an involvement of public and private higher education institutions.

In overall, 21 HEIs participated in the competition, 10 of which represented 6 regional universities (total number of applications: 30).

14 public/LEPL (including 8 regional) and 7 private HEIs were among the applicants.



A VARIETY OF FIELDS

Every academic field had an equal opportunity to participate in the CIF's first call for proposals. As a result, the funded projects contribute to the development of the disciplines as follows: Social Work and Psychology, Medicine, Healthcare, Business, Music Education, Engineering, Law, Computational Social Sciences, Entrepreneurial education.

innovation, encouragement of cooperation,
and sustainability of project results.

INNOVATION

Encouraging innovation in the higher education institutions is a cornerstone of the Competitive Innovation Fund and a guarantee of its effectiveness.

Implementation of the projects funded in the first call will result in establishment of:

- innovative research components;
- new academic programs and courses;
- multidisciplinary learning practical laboratories (hub) promoting employment of people with disabilities;
- Transcranial Magnetic Stimulation Somatic Therapy Method Implementation for Enhancing mental health;
- OSTE stations, etc.

Consequently, CIF grant funding will contribute to modernisation of the academic environment, development of learning-teaching methodology and strengthening the labour market linkages.

PARTNERSHIP


Along with creating a healthy competitive environment in the higher education system, CIF aims to promote cooperation among local and international public and/or private universities, as well as to foster the partnership of HEIs with the local and/or international research, governmental and non-governmental organisations.

CIF grants were awarded to the projects elaborated in frames of consortia comprising both public and private, local and international universities. The Georgian HEIs cooperate with San Diego State University (USA), Keele university (England), Linkoping university (Sweden) and Terassa University (Spain).

Noteworthy is that in frames of the CIF grant proposals, important partnerships were also established with the private sector representatives.



Systematisation of the best practices (introduced in frames of the CIF grant competitions) is one of the key indicators of the fund's success. As the projects' implementation finishes, elaborated/upgraded academic programs and the acquired equipment will further contribute to creation of new knowledge, development of modern teaching methods and laboratory/ research components.



The First CIF Call for Proposals announced for HEIs

Priorities for the 1st Call:

- Elaboration/development of academic programs in cooperation with a foreign higher education institution recognized in accordance with the legislation of a foreign country for the purpose of awarding joint/double academic degrees and/or promoting international accreditation.
- Development of educational programs tailored to the labour market needs (including specific needs of the Georgian regions) (Smart Specialisation, Third Mission etc.).
- Development of practice oriented educational programs.
- Supporting cooperation with industry/private sector (creation/development of joint educational programs tailored to employers' needs (joint teaching/practice, research/other initiatives on different levels of education, including structured doctoral programs).
- Initiating projects/programs developing/enhancing entrepreneurship education.


Consultation meetings cycle with the representatives of HEIs.

In the first CIF grant competition, 13 grant proposals received funding of up to 2.1 million USD, in total.




